Six-month suspension strips Zeron and Atlanta of possible O'Briens

By rule, trainer's 180-day suspension made him and his star filly ineligible for Canada's highest annual harness racing honors. Standardbred Canada president and CEO Dan Gall explains why it was the correct decision — even with Atlanta as a favorite for the nation's Horse of the Year award.

Trainer Rick Zeron (at the Meadowlands last August on the day his filly Atlanta won the Hambletonian) is facing a 180-day suspension and \$10,000 fine in Ontario. He and Atlanta have been stripped of the right to earn O'Brien Awards.

Standardbred Canada president and CEO Dan Gall said stripping Rick Zeron and his star trotting filly Atlanta of the chance to earn O'Brien Awards is simply the correct course of action, nothing more.

Friday, two days after the Alcohol and Gaming Commission of Ontario (AGCO) that regulates the sport in the province released a notice saying Zeron is facing a 180-day suspension and \$10,000 fine (see sidebar on pg 3 for details on his suspension), Standardbred Canada announced it had disqualified both Zeron as a finalist for the 2018 O'Brien Award of Horsemanship and 3-year-old trotting filly, Atlanta, trained and co-owned by Zeron.

"My quote on the press release was 'It's not a good day for anybody. No one should be happy about this' and I meant that in every way, shape and form," Gall told HRU on Saturday. "It's not a happy day for the co-owners, it's not a happy day for Mr. Zeron, not a happy day for Atlanta and not a happy day for us, because we're not able to celebrate what we'd like to celebrate, but what's the right thing to do? The right thing to do is start putting integrity and transparency back onto the table. If we don't, who is going to?"

Though the winners of O'Brien Awards are not announced until the night of the gala, it is widely believed Atlanta, who defeated the boys in the 2018 Hambletonian, would easily win the award as Canada's Three-Year-Old Trotting Filly and was on the short list of favorites for the nation's overall Horse of the Year award.

Guy Gagnon, the other finalist in the Horsemanship category has been acclaimed as the winner, and Illusioneesta, the other finalist in the sophomore trotting filly category, will be honored as the O'Brien winner on Feb. 2 at the O'Brien Awards Gala held in Mississauga, ON.

Standardbred Canada has long had a policy that reads: "An O'Brien Award will not be presented to any individual or entity who has served, or is currently serving a penalty for a continued period of 180 days or more during a calendar year. If the penalty continues through any part of the following calendar year, said individual is also ineligible for an O'Brien Award in the second year of the penalty. Outstanding appeals and/or stays do not alter the conditions of eligibility for O'Brien Award consideration."

Two messages to Zeron requesting comment were not returned prior to press time, but whether he appeals the AGCO suspension is irrelevant, Gall said. The rule is clear.

What was less clear at press time was whether Zeron's suspension and fine will strip Atlanta of the Dan Patch Award she has already earned from the United States

Harness Writers Association (USHWA) as the nation's top sophomore trotting filly and whether it will impact her eligibility for both the Trotter of the Year and Horse of the Year awards yet to be announced. HRU has asked for clarification from USHWA and will provide an update when information is available.

The trigger for Zeron being declared ineligible in Canada was the 180-day suspension, Gall said. That explains why Caviart Ally is still a finalist for an O'Brien Award in the Older Pacing Mare division. Her trainer, Noel Daley, is facing a similar suspension for alleged shockwave therapy violations as Zeron, but Daley's 90-day suspension from the New Jersey Racing Commission (see sidebar) is below the O'Brien Awards' threshold to be declared ineligible.

Gall said he thinks, "the O'Brien Awards committee needs to review that (threshold) and discuss whether that 180 days should be less. I do think it needs to be less. We need to be a lot more restrictive in the way we're giving out the awards, for those that are getting in and qualifying. That would be my position going into our committee discussions and that's what I would be lobbying for."

Asked what number of suspension days might be acceptable, Gall said, "What about zero? I'd love to hear why there should be an exception and I'm sure I would hear that, but my starting point would be why are we looking at horses or trainers that have any kind of a suspension going into these awards?"

Gall said O'Brien Committee chair Bill McLinchey of Woodbine said he would like to set up a meeting as soon as possible to examine the possibility of altering the integrity portion of the eligibility rule.

"This has given us a second sober thought about what we're doing and why we're doing what we're doing," Gall said. "And having that on the table now, we should start moving forward on having more discussions about it."

As for the Zeron case, Gall said Standardbred Canada was thorough in its deliberations before it came to a decision.

"When this was brought to our attention by the AGCO ruling, we obviously read it and we wanted to make sure we understood what all of the infractions were and it was a long list of them. Automatically, internally from an administration position, we knew that we had to disqualify Mr. Zeron (from being a finalist for the Horsemanship Award)," Gall said.

"Then we had the discussion about the three-year-old filly Atlanta. We were looking at that aspect as well – how does this or does it impact that horse? The administration believed that there was a serious discussion that we needed to have about the horse because Rick is not only the trainer, but he is also a co-owner. As a co-owner, we viewed that as an 'entity' because if you look at our policy it is for any individual or entity currently serving a penalty of 180 days (or more).

"That was our position, but we thought 'Let's get some people involved in the discussions and we convened a meeting – a teleconference – with the O'Brien's committee and the Standardbred Canada executive committee together.' On the phone, we had a spirited debate on... the one for Mr. Zeron was not up for discussion, because we were within our rights in upholding our policy to disqualify Rick. With the horse, Atlanta, we had a discussion around that There were questions about precedent. There were questions about history. There were questions about how we interpret it. We all came down to the decision that Atlanta should be disqualified as well."

Gall said the next step was to communicate the decision to Zeron and Atlanta's other connections. That happened Friday morning, followed by a press release being issued Friday afternoon.

"We wanted to be as hands on the table as we could, with respect to the decision, to explain and talk to the co-owners and then make the announcement," Gall said.

He said it was well understood the decision would lead to more bad press for a sport that has had more than its share, but in the initial deliberations he said he asked his team at Standardbred Canada to put aside politics and determine the correct course of action.

"I think, as an industry, we need to start asking those kinds of questions, 'What's the right thing to do on this one?' I think there's a lot of people that would have some very good input and insight on it, but we need to start focusing on the integrity of the game and of the sport and celebrate that piece, as opposed to worrying about what the political

fallout might be or whether we win a popularity contest or not," Gall said. "We just want to do the right thing."

6.05 — Any attempt to violate any of the rules of the Commission falling short of actual accomplishment shall constitute a violation of the Rules.

6.17D — A person, at any time or place, shall not against any official or participant:

(d) engage in any improper conduct.

6.52 – The use of Extracorporeal Shock Wave Therapy or Radial Pulse Wave Therapy shall not be permitted on any racehorse unless the following conditions are met:

(a) the treatment took place a minimum of 4 days (96 hours) prior to competing in a race;

(b) the treatment using the Extracorporeal Shock Wave Therapy or Radial Pulse Wave Therapy machine was conducted by a veterinarian licensed by the Commission as a veterinarian;

(c) any treatment received while on the grounds of the Association was through the use of an Extracorporeal Shock Wave Therapy or Radial Pulse Wave Therapy machine owned and operated by a veterinarian licensed by the Commission; and



NJRC explanation:

As a result of the evidence and testimony presented in the administrative hearing conducted on Thursday, Oct. 18, 2018, the Board of Judges has determined that Noel Daley on May 13, 2018 did possess a shockwave therapy machine in his stabling area at Magical Acres Farm, which is an off-track stabling facility that is licensed by and under the jurisdiction of the New Jersey Racing Commission. The possession of a shockwave therapy machine by any person other than a licensed veterinarian at any racetrack, off-track stabling facility, or other location subject to the jurisdiction of the New Jersey Racing Commission is in direct violation of NJ.A.C. 13:71-23.17a. As a result, Mr. Daley is hereby issued a full suspension of his New Jersey Racing Commission license for a period of thirty (30) days and fined the sum of two

thousand five hundred (\$2,500.00) dollars. On May 13, 2018 Mr. Daley did possess in his stabling area at Magical Acres Farm numerous bottles of injectable therapeutic medications, as well as hypodermic needles and a syringe. This is in direct violation of N.J.A.C. 13:71-23.9(a). No person aside from licensed veterinarians shall have in his/her possession anywhere within the grounds of an association conducting a race meeting, or anywhere within the confines of a racetrack enclosure, or anywhere within the grounds of any licensed off-track stabling facility, any drugs not possessed in accordance with the laws of the state of New Jersey, nor any contraband drug or unauthorized prescription legend drugs, nor any hypodermic syringes or needles, etc. As a result, Mr. Daley is hereby issued a full suspension of his New Jersey Racing Commission license for a period of ninety (90) days and fined the sum of seven thousand five hundred (\$7,500.00) dollars. The suspensions of 30 days and 90 days shall be served concurrently, and Mr. Daley is fined the total sum of ten thousand (\$10,000.00) dollars. The period of suspension shall begin on November 25, 2018 and continue through February 22, 2019 inclusive. During the period of suspension, Mr. Daley is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. Violation of N.J.A.C. 13:71-1.19.

WEG needs to fix HPI before using it to accept sports bets

There was a buzz in the news this week in Toronto around the Woodbine Entertainment Group (WEG) putting its oar in the water regarding individual game sports betting, which would in turn benefit their racing operations.

Woodbine CEO Jim Lawson indicated in a **Toronto Sun article** written by Rob Longley his strong interest in getting his company involved in what could be a boon for Woodbine. "Sports betting is very much on our radar screen," Lawson said. "We are very strong believers that with the infrastructure of our tote system and our (online wagering system, HPI) that we already have the whole backbone to run sports betting. We think that not only do we have a lot to offer, but we need to participate in sports wagering."

While Woodbine's potential involvement does seem to offer some promise for the province's horse racing industry, it was Lawson's statement about the company's wagering platform which seemed to suggest it would be turnkey for accepting sports wagering that stuck with me.

The HPI online wagering platform is a monopoly in Ontario as current laws forbid Canadians from opening accounts with similar American betting sites. That presents several problems for local bettors when betting tracks outside of the country.

Problem number one is different and higher takeout rates due to the WEG group charging a higher price to bettors at many U.S. tracks. Now, I am no expert on cost of accepting other signals and all that goes into that and it is likely a factor in the higher pricing, but one thing I can tell you with reasonable certainty is if you charge customers a higher price than what they believe give them a fair chance of winning, they'll start taking their action elsewhere. This is especially true when their wagering rivals are betting at a lower takeout rate. There is no way sports betting will work here if there are egregious differences in the traditional 10 per cent "juice" charged on each single game wager.

The best way to describe problem number two – differing minimum wagers — is by recounting a recent personal experience encountered when I tried to bet into a big carryover pool.

Charles Town Racecourse isn't a track I typically play, but when I saw several tweets trumpeting a \$250,000 carryover into a mandatory payout pool with a 20-cent minimum bet, I knew this was likely going to be a zero takeout situation, the best betting opportunity in horse racing, if not any form of gambling. I had to jump in.

I spent close to two hours studying past performances, watching replays and constructing my play, finally deciding on a \$288 ticket – a large wager for me – which I was convinced would connect. Imagine my surprise when I opened my HPI account to discover that the minimum bet on this Pick 6 was \$2! This wildly different minimum bet would increase the cost of my ticket tenfold, and I wasn't playing a \$2,880 ticket.

As it turned out, I got five of six winners and would have lost my \$288, but that's not the point. I wondered how much takeout HPI missed out on from bettors who like me didn't play at all because of the disadvantageous higher minimum.

Now, I'm not going to suggest that any of this is Woodbine's fault per se, I imagine there is an issue with the source track being willing to accept the 20-cent bets from Canada. But this kind of thing has been an issue for bettors here for years with no end to the confusion in sight. It is insulting to a bettor who has spent hours working on tickets to open his account page and see that the minimum bet makes the wager unplayable, and Woodbine should care about that from a customer experience perspective. Heck, you still can't bet dime Supers up here, with the lowest minimum bet being 20 cents for reasons unknown.


In a nutshell, the current HPI system is broken for horseplayers. Shouldn't that get fixed before anyone starts thinking about placing sports bets through the system?

A new five-year contract between WEG and COSA will add \$15 million to purses at Woodbine Mohawk Park over the life of the contract.

WEG and COSA add \$15 million in purses with new five-year deal

Additional purse money will be distributed over the course of the deal.

Woodbine Entertainment Group (WEG) and the Central Ontario Standardbred Association (COSA) jointly announced Friday the agreement in principle of a new five-year deal that includes an investment in capital upgrades and an increase in purses, further solidifying Woodbine Mohawk Park as one of the leaders in total purses paid for standardbred racetracks in North America.

The new deal is highlighted by \$15 million in additional purse money to be distributed over the course of the contract.

Woodbine Entertainment has also committed to \$1 million in capital upgrades to Woodbine Mohawk Park annually over the five-year period, a further demonstration of its commitment to the standardbred horse racing industry in

Ontario.

"This new five-year deal is part of our commitment to standardbred racing, and the vision to grow year-round racing at our world-class facility in Milton," said Jim Lawson, CEO, Woodbine Entertainment. "This long-term deal gives standardbred breeders and owners the opportunity to plan and invest with confidence."

"COSA is pleased to come to terms on a new five-year deal with Woodbine, providing purse growth each year for the next five years for our members," said Bill O'Donnell, president of COSA. "We have developed a strong working relationship with Woodbine and will continue to work closely with them to reach goals for both sides during this new contract."

Woodbine Mohawk Park reopened for the 2019 racing season on Jan. 5. A total of 221 live race dates are scheduled for the upcoming season, highlighted by the Pepsi North America Cup and the 2019 Breeders' Crown.

The Deck was busy despite overcast, windy morning

I have been asked about why my attention is concentrated on certain barns. This is not so at all. There are almost 300 horses to watch, but I only write about the ones that catch my eye. If I wrote about some ill-gaited beast that the trainer has already suggested turnout and the owner reads that I thought it was a nice horse there would be hell to pay. Many nice horses are omitted because some trainers refuse to use numbers to identify the colts and now that the season is in full swing I am assuming that the guilty parties don't want the eyes of the industry on them.

The Deck was mobbed Saturday even on an overcast windy morning and there was plenty of vigilantes and hanging judges in the Rick Zeron case. I suggest all of you not to be judgmental until all the facts are known.

On the track, sanity seems to prevail with most of the miles in the 3:00 range. The only one I caught speeding was the Fred Grant trained and driven **Power Play Goal**, the Muscle Mass colt from Finesse Hanover was full of himself once again in a flashy 2:50 mile with a final panel in 38 seconds.

Tony Alagna, as usual, had the largest offering. The Muscle Hill filly **Romona Hill** (out of Lock Down Lindy) was great heading a bunch of pacers including **Pure Essence** (Western Ideal—My Little Artist) and **Libspeak** (Artspeak—Docdor Libby).

Sea Of Life was next with a nice 3-minute mile. The Captaintreacherous colt from Fresh Idea is as slick as they come.

Three first-time eye catchers in the next set were: Hopefully Inclined (c, Mach Three—Artistically Inclined), Captain Barbossa (c, Captaintreacherous—Swinging Beauty), and Major Risky (c, Captaintreacherous—Flyonce) all looking sharp in their work. The Mach Three colt was driven by Hall of Famer and long-time friend Cat Manzi who will be spending about a month and a half in south Florida. He still looks like a kid to me.

Force And Fury (c, Captaintreacherous—My Little Dragon) was once again a man amongst boys in a more than fantastic showing. Two more newcomers to the column were Jazz Fest (f Captaintreacherous—Jan It Jackson) and Creative Power (f, Artspeak—Shyaway both seem to have bright futures in Tony's care.

Odds On Daytona (c, American Ideal—Odds On Moinet) and Puzzling (c, Somebeachsomewhere—Suduko) from the Webster-Crogan Stable both looked great going one of the

faster miles of the morning. Two repeat eye catchers were **Pick Me Upper** (c, Trixton— Pick Me Up) and **Wired Sweet** (f, Sweet Lou—Live Wire) both from the same barn.

Fool Who Rocks (c, Artspeak—Fool Who Rocks) made a major move for the lovely Megan Scran to come from last to first in a large mixed set of about eight colts and was well in hand doing it. The flashy colt **Sixteen** (Donato Hanover—Mets Inn) and a nice lass **Val Halla** both from the Rick Zeron stable were sharp and good gaited.

A pair of Explosive Matter homebreds looked fine on display from Jan Johnson. **Hot Springs Volo,** a filly from Silver Springs and **Higher Call,** a colt from Bruschette, went very well.

Four repeat performers from Paul Kelley looked great again: Amos Hart (c Trixton—Zeta Jones), Tumult (c Father Patrick—Graceful Kelly), Mambo (f Yankee Glide—Dance To Market) and Flying Glider (f Cantab Hall—Highland Glider) were all good gaited in a fairly quick mile.

Unnamed (f Love You—Born Lindy), **Unnamed** (f Muscle Hill—Moms Millionaire) and **Sweet Lucille** (f Sweet Lou—Dancin Barefoot) for Lindy Farm (Domenico Cecere) all looked very professional finishing the mile together.

Please note that if you are not familiar with Sunshine Meadows the speeds recorded are far slower than the normal stone dust tracks or clay tracks in other areas. A mile in 3:00 here is equivalent to a mile in 2:45 on a track like the Meadowlands or any good training track for that matter. In the years I used this facility I would rarely beat 2:20 with my colts before going to New Jersey. Those horses would easily trot 2:08 when we reached the Meadowlands or even Pocono Downs. So keep that in mind as I report training miles in the future.

Can it be 40 years already since Campbell stormed on the scene?

Can it really be 40 years since John Campbell stormed on the scene by winning the first of 16 Meadowlands driving titles?

Campbell was just 24 in 1979, and his 177 wins earned him the Big M title.

It was also 40 years ago that he won his first \$100,000. On May 24, 1979, Campbell won the \$108,000 Oliver Wendell Holmes driving Merry Isle to victory in a 14-horse field. Merry Isle was the favorite and winner. Second place Hot Hitter was the third choice in the wagering and would on to capture divisional honors (the second choice was 4.00-1 Good To See You who was eighth from post 14; Genghis Khan was also in there and finished seventh for Eddie Cobb at 38-1). Seven future Hall Of Famers drove in this race, including: Campbell, Herve Filion, Del Insko and Ted Wing.

It was also 40 years ago that Niatross stepped onto the track for the first time and would go unblemished and be named Horse of the Year after a perfect 13-for-13 campaign. He won the \$862,750 Wilson that year to nail it down. He would repeat his HOY heroics at 3 and to this day remains the last standardbred to be so named at both 2 & 3 in the United States (Somebeachsomewhere equalled the feat in Canada thanks to a HOY tie at 2 with sophomore Tell All and a win, outright, at age 3). Niatross joined both Bret Hanover (1964) and Nevele Pride (1967) to be unanimously voted their division's best.

It was also 40 years ago that Hanover Shoe Farms had a rare trifecta in the Hambletonian. They were 1-2-3 in summary and finish with all three broodmares named 'Hanover'.

- 1. Legend Hanover out of Laurita Hanover
- 2. Chiola Hanover out of Clorita Hanover
- 3. Butch Lobell out of Briana Hanover

Big M openers through the years

Opening Night through the years at the Meadowlands was often the second week of January, or later. Here's a look at some memorable ones:

Jan. 19, 1978 – The highest Opening Night win price occurred

when Gypsy Hill Night paid \$91.20 for Joe Greene. Track was "good" for all 10 races.

Jan. 12, 1979 — No winning favorites all night and no driver repeats.

Jan. 12, 1980 — Sloppy and then slow going all night. One of the three slowest nights in Meadowlands history; Campbell won four times. The fastest mile of the night was the 2:05 by Newt Lobell. The slowest was 2:08 by Columbia Brooks.

Jan. 9, 1981 — The meet opens with two-time defending leading driver Campbell winning with Spanish Scirocco. J Ds Buck overcomes the 21-degree temps to score in the feature in 1:56.1.

Jan. 8, 1982 — JoAnn Looney becomes the first female driver to take the opener (Henry The Eighth). Genghis Khan-who would go on to win a record 16 Meadowlands races in a single meeting, was third on this night in the \$35,000 invitational.

Jan. 10, 1983 — Nilmot Ernie takes the featured \$30,000 trot over a sloppy track in 2:04.2. Walter Case, Jr. makes his New Jersey debut finishing second with Master Regal N.

Jan. 10, 1985 — Doubles for Bill O'Donnell and Ray Remmen, a triple for Campbell and Boomer Drummond scores in a strong \$35,000 invite. Tuff Choice began his record 13-race win streak for trainer Joe Holloway.

Jan. 9, 1986 — Lustras Big Guy for Bob McIntosh overpowers his rivals in the invitational. He wins in 1:55.4 over veteran Hoosier Hotshot, who would wind up his career with 99 victories.

Nancy Johansson – Like father, like daughter

Following in your parents' footsteps can be a hard act to follow, especially for Nancy Takter Johansson. After all, it will be almost impossible for anyone to live up to what her father, Hall of Famer trainer Jimmy Takter, has accomplished in the business.

Takter, the son of renowned Swedish trainer Bo William Takter began driving at an early age and won his first race at age 18 in Malmo, Sweden. When he moved to the United States in 1978 he worked for Continental Farms before returning to Sweden to marry his childhood sweetheart, Christina. Two years later, the newlyweds moved back to the United States and started a family of four children: Nancy, Jenny, Tiffany and Jimmy Jr. It didn't take long before Takter was one of the leading trainers on the Grand Circuit.

He has conditioned and trained many world champions such as: Malabar Man, Enjoy Lavec, Always B Miki, Kadabra, Nuncio, Moni Maker, Trixton, Father Patrick, and Tactical Landing among many more, and earned over \$130 million in purses. Jimmy is also a six-time Trainer of the Year.

In 2018, Takter announced that he was ready to retire and would be turning his reins over to his daughter, Nancy, along with top assistant trainer Per Englom.

It is no surprise that his daughter Nancy started working in the barn at a young age.

"I was always in the barn as a child. When we moved to the USA I was 1 $\frac{1}{2}$ years old. Dad went to work for Soren Nordin and at that time it was just my dad, mom, and I," Johansson said.

When Nancy was 3 years old, she helped Marcia Hamilton, the groom of Baltic Speed, care for the champion.

"Shortly later, dad got a couple horses he trained on the side, so my mom and I would help take care of them. I would go to the barn every weekend, helping him jog, brush and

bathe the horses and when I turned 8 or 9 I started to train a little. We had a big pacing colt named Lansford Hanover that I trained. I remember going a mile in 2:10 thinking that was pretty cool!

"Lansford will always mean a lot to me, although I can't pick a favorite. Every horse has a story. JK She'salady was pure talent. Not only was she a sweetheart to be around, but accomplished everything on the track.

"Then there's Western Vintage aka/ Gator who is so special for he put me on the map in the Grand Circuit the first year I had my own stable. He was a \$7,000 yearling and swept the New Jersey Sires Stakes, was second in the Metro, and won in Lexington in 1:49.4 at 2."

Johansson said Kissin In The Sand is another favorite, "but she was a handful! I remember telling her owner Marvin Katz in January of her 2-year-old year, 'She's either going to be really good or really bad — there will be no in between.'

Kissin and I have a real bond. She doesn't really trust anyone but she loves me. I'm her person. Even though I was really busy last year, I made sure I took care of her myself. The end results showed it was all worth it. But I need her as much as she needs me. Unlike many trainers that have a life when they are done at the barn and go golfing to unwind — me, I have Kissin.

"Kissin In The Sand is from a great maternal family — one of the best in the sport. She is by Somebeachsomewhere. She's big, long legged and has perfect conformation. She is as tough as they come and never gives up — be it in a race or when I give her a haircut. She's the complete package."

As far as drivers, Johansson said her favorites are Scott Zeron, Yannick Gingras, Matt Kakaley and Andrew McCarthy.

"I think it's important for a driver and trainer to communicate. Drivers are important in the sport, but personally I feel they get a little too much credit because they are only as good as the horse they are driving. I think Ron Pierce was the best of all time. I wish he were still driving since I have my own stable now," Johansson said.

"I prefer not to drive in the race. There are professionals for that and I leave it to them. However, I have contemplated driving in more qualifiers when I want more of an idea of what's going on with a horse in a race. Also, a lot of catch drivers don't like to get up early in the morning when they have been driving in late races."

Johansson is married to trainer/driver Marcus Johansson. "My husband is also a very good driver who has a great set of hands, especially when a horse needs to be babied a little. Marcus has that special touch they need and is the BEST at breaking babies. Luckily, we work very well together.

"As far as our children, we have a boy, Marcus Jr., and a girl, Ella. Although they both really like the horses, I don't see them being as involved in harness racing as I am. I see Ella

being an owner and she obviously has 'an eye' in picking one out. After all, she is the one who picked out Captain Crunch.

"It was love at first sight for Ella and the son of Captaintreacherous, out of Sweet Paprika, (from the family of Dan Patch Award-winner Sweet Lou and \$2.78 million-earner Bettor Sweet). She spotted him at the sale and begged me to buy him. I also liked the colt for he is a big, strong, good-looking horse, but I wasn't sure we would get him. I put together a group of owners, set a budget and was lucky enough to have the last bid at \$85,000."

Lucky indeed, for Captain Crunch won the \$600,000 Breeders Crown for 2-year-old male pacers, along with The Governor Cup and amassed \$616,113 for the year.

As far as feeling pressure in walking in her father's footsteps, Nancy said she is not concerned.

"Dad has had a great career and I don't think anyone expects me to top it. I do expect to maintain the same professionalism that he has had through his career and get the same results. I can't worry about being in his shadow or my grandfather's, who was a HUGE trainer in Sweden. I'm sure my dad felt the same thing about being in his shadow.

"I admit that I do get a little annoyed when I'm introduced as 'Hall of Fame' trainer Jimmy Takter's daughter. After all, I've had my own stable since 2014 and have trained three Dan Patch winners, one O'Brien winner, and 'The Horse of the Year' in both the USA and Canada. I feel like I have a nice enough resume that I don't need to be introduced as his daughter anymore."

Almost time to call it a Night

Former Indiana Sires Stakes champion Night Pro is coming to the end of his terrific racing career before heading off to stud duty in the Hoosier State.

Each time Dale Decker slips onto the bike and sits behind free-for-all pacer Night Pro, he knows it is one trip closer to the end. The owner/trainer/driver arranged last fall to stand the son of Pro Bono Best stud in Indiana in 2019. The former Indiana Sires Stakes champion and winner of more than \$940,000 will stand at Schwartz Boarding Farm, but until then, Decker is making the most of his final opportunities. Night Pro lined up behind the gate in his second seasonal start Saturday night at Miami Valley Raceway in an \$18,000 contest for stallions and geldings, finishing a close third.

Decker has always considered standing Night Pro at the conclusion of his racing career. So the timing was right when Alvin Schwartz reached out to him last summer. At the time, the pacer was sidelined with lameness issues, and the owner was not sure he would return to racing. It is only the second time in six seasons that issues had derailed a campaign. As a 5-year-old, a stifle injury jeopardized Night Pro's career.

"The tear that he had at five, I knew he was off in the stifle,

but couldn't figure out what it was. I took him to Michigan State and they found he had a tear in the stifle under the kneecap," Decker explained. "The doctor gave him a 50-50 chance of a return to the races. If he did make it, he wasn't going to be the horse that he was. Well, he is such a tough horse because he proved that wrong."

Before the injury, Night Pro banked a little over \$500,000 during his 3-, 4- and abbreviated 5-year-old campaign. Since then, he has earned another \$430,000 battling in the top classes in the Midwest with a few stakes events mixed in each year. Last season, the stallion accumulated four wins and was on track to becoming a millionaire when lameness struck in June.

"Honestly, I had him off all summer. He probably could have been off a few weeks, bandaged up and motored on. But I don't like doing that with him or any other horse. Give him the time and let him heal completely and see if he'll come back," the owner said. "He has, and it's a testament to the horse himself. He likes to race."

Night Pro resurfaced in a qualifier at Northfield Park on Sept. 27. By that time, an agreement had been reached to stand him at Schwartz Boarding Farm in 2019. Decker said that he normally would race the veteran three weeks in a row followed by a week off. Since returning to action Oct. 5

at Harrah's Hoosier Park, Night Pro has competed weekly, taking off only once in December.

"He's been racing now more than I typically would have raced him in his career because I know the end is coming," he said. "I've been racing him pretty aggressive knowing that he's only got a couple of starts left at best."

Utilizing the form that has defined his career, Night Pro is again displaying his toughness. Since his return, the pacer has registered two wins, finished second five times and was three times a third-place finisher in 14 attempts. In the runner-up finishes, Night Pro has been beaten by a neck three times, a head once, and finished a half-length back on the other occasion.

"He's nine now. He's lost that last 100 yards in the race. He's been beaten three or four times by a neck or a head here since he's come back. I think age is catching up with him a little bit. It's time," Decker said. "He's just a nice, classy horse. He's not nasty; he doesn't try to kick and bite. He's a classy horse to be around."

How well Decker's charge transitions into the breeding shed remains a question. The owner knows that the landscape is ultra-competitive, and that it will be tough for Night Pro to crack the top ranks. He is hopeful that breeders will remember the guts and tenacity the stallion showed on the track. Race timed in 1:48.4, the bay took his 1:49 mark at three battling at Hoosier Park. He has a 59-36-9 record over 136 starts.

"Breeding has always been on my mind even if nobody else would breed to him. He doesn't have that (1):47 mark that I think he would have if he was out at the Meadowlands. It is what it is because I had no intentions of sending him off," Decker said. "I would be satisfied if he was able to breed 50 mares; that would be a good number. When I'm at the track, I talk to guys and they tell me they are sending a mare, some say two. We'll see how that pans out."

Out of the world champion Midnight Jewel, Night Pro will stand for an introductory fee of \$2,500. The price is reasonable for a stallion trying to break into Indiana's crowded landscape. Schwartz said that right around 30 mares are already committed for the breeding season.

Until the horse departs for stud duties, Decker is savoring the remaining few starts that will cap Night Pro's impressive career. He has yet to reflect on the stallion's accomplishments. There will be time for that later.

"Honestly, I don't think that's going to sink in until he's done racing. I'm so busy building houses and racing horses on the side, I really haven't had much time to reflect on that," he said. "I do know for a guy like me it's a hell of an achievement, for what he's achieved. It's special for sure."

Clay Horner proposes new format for Breeders Crown

Further to John Campbell's defence of Breeders Crown eliminations (full story here) and Ron Gurfein's contempt for eliminations generally, I have a proposal for the Breeders Crown format. It is informed by these principles:

- 1. I don't want our bettors and fans to have "bettors beware" races as a general matter, but particularly I don't want them as part of our industry showcase. It is wrong.
- 2. Presently, the Breeders Crown is really the Tracks and Owners Crown; the stallion owners need to pay significantly more.
- 3. Recent years show us that low earners rarely are serious contenders.
- 4. We should avoid situations where a single trainer dominates the starters in any race; it isn't good for our bettors and credibility.
- 5. We should increase the significance of our top Grand Circuit races as stepping stones to the Breeders Crown.
- 6. We should limit the number of preferential starting positions to further increase the betting profile of our Finals.
- 7. Two-year-old Finals shall have 10 starters; three-year-old and aged races may have 12 starters. Again, this enhances the betting profile.

Accordingly, my proposal is:

- 1. The winners of the two highest purse Grand Circuit races for the division shall have an automatic right of entry (at normal fees if eligible and at supplementary amount if not).
- 2. The highest money winner in the division shall have an automatic right of entry if not a horse in point 1.
- 3. If there are 18 or more entrants, there shall be two eliminations for up to the highest 22 money earners. The first two finishers in each elimination shall qualify. Horses in categories 1 and 2 may start in eliminations but will lose their entry status unless they finish first or second. Eliminations will go for \$75,000.
- 4. Other entrants (whether eliminations or not) shall be determined on the basis of seasonal earnings with earnings

in the eliminations credited at five times (i.e. third in an elimination shall be worth \$50,000 in seasonal earnings). This would generally be three or four of the two-year-old finalists and up to six or seven of the three-year-old finalists if all category 1 and 2 horses enter and more if they don't.

- 5. To protect the interests of the "true believers" in their lower-earning horses (or those breaking in an elimination, for example), one spot in the two-year-old finals and two spots in the other finals will be available for eligible horses at a \$75,000 entry fee (drawn by lot if more applicants than spots).
- 6, Horses qualifying under categories 1 and 2 and the winner of any elimination will draw by lot (an elimination winner that is also a category 1 or 2 horse will have two pills) for two preferred starting positions of 1-6 on a big track and 1-5 on a smaller track. Others in those situations will participate in the rest of field draw. Any of the category 1 or 2 or elimination winners shall have the right to elect not drawing a trailing position.
- 7. The Breeders Crown races increasingly are races for the offspring of the very top stallions. They are important credits for these stallions which sell a huge share of the top priced yearlings. Breeders Crown fees for owners are high. Stallion owners must do more. At present, a stallion with a \$10,000 fee pays \$30,000 but may have an annual service value in excess of \$1,000,000 in North America alone and may sell well a several times multiple of that in yearlings. Stallions with fees at \$15,000 or above should have a fee of \$150,000; those between \$10,000 and \$15,000 should have a fee of \$100,000 and those between \$5,000 and \$9,999 should have a fee of \$50,000 if they breed 100 mares or more and \$35,000 if they breed fewer than 100 mares. I'll leave the fee for cheaper stallions to others but the minimum fee should be \$10,000.
- 8. Trainers should be limited to two entrants in a Final (increased to three if they have a category 1 or 2 qualifier).

Harness racing yays and nays

Mr. Campbell's article (full article here) while being well meant, demonstrates the disconnect between those in charge of the general health of our sport and the reality "on the ground". To think that our current judging overseers will police the racing integrity is just plain naive and does little to alleviate our current concerns/issues. If those in charge of INTEGRITY were really in our corner then elimination races could still be run, but would be designated as "Non Betting" races. But, what we have are "Money Grabbers" whose sole

purpose is to line their pockets with their 22 per cent (or excessively more as is the case in Pennsylvania) take-out of all monies wagered — NOT doing the right thing for their customers. This is the mentality of our overseers.

So, can we rely on the racing officials to police themselves and do the right and fair thing for us? Let's look at a few examples outside of racing. First, take the American government, while we have permitted them to control and regulate our dollars, there is NO current program where they have demonstrated proficiency at successfully managing even break even. Or, let's look at the police departments across the country, when was the last time an internal police review board found officers wrong in egregious behavior? So, Mr. Campbell you want to bring positive, effective change, throw away the current playbook and start over and stop listening to the money grabbers telling you what can't be done. And, time is short because once the casino portion of the racinos across the country bring in sports betting, the racing bottom line will plummet.

Okay. If you want elims for all the reasons Campbell talks about, make them non betting. Give the gambler a shot in the finals, when going to the bottom matters. Or try this:

summarize Campbell's logic, insert it on the program page boldly beneath the race conditions. In short, you're a desperate fool betting on this race. The trainer and the driver have an incentive to finish no worse than fifth.

Riordan corrects The Guru on French racing

After reading Ronnie's response to Neil Zelkin's question about French racing (full response here) I was struck by one thought... I wonder if the last time Ronnie was in France had Édith Piaf become a star yet?

Just in case anyone is interested, the French stud book was opened. And it had a profound effect on the French breed. Since the '90s almost all the French winners of the PD'A (Prix d'Amerique) have had a healthy dose of American blood. Both top and bottom. And not way back. Close. And regarding Ronnie's stereotype of the French trotter. There is no typical size. Cocktail Jet was small. Offshore Dream and Bold Eagle are below medium. Of course there have been big French horses winning also. But if you are looking for a common denominator in French winners of the PD'A, or any winners for that matter, it is not size. And as far as disparaging the American trotter because they are not competitive in the PD'A, nothing could be further from the truth. Considering the limited participation of American trotters, the success rate has been phenomenal. Going back to the Hanovers - Nike, Delmonica and Dart. Then Sea Cove. And of course the great Moni Maker. European bred but essentially American pedigreed horses have also won frequently. Ina Scot, Abano As, Giant Neo, Varenne, and Maharajah are all completely or almost Americans.

Regarding who can participate in the PD'A. The Guru got that wrong, too. Like the final of every other sport, there are eliminations, or in this case qualifications, to determine who gets in. During the winter meet at Vincennes there are six races that are part of the Equipe Series. In four of these races, the first three finishers are guaranteed a spot in the PD'A. In the two other races, the Prix Continental, for 4-year-olds and the Prix Tenor de Baune for 5-year-olds, only the winners qualify. So theoretically you could have 14 of the PD'A starters determined by horses who qualified from the Equipe Series. The remaining starting slots would then go to the highest money winners not yet qualified — with an earnings adjusted allowance for younger horses. The whole series is entertaining, and from a betting point of view, intriguing. A bettor can try to use who is qualified and who is

not as part of his betting strategy. Or he may make a token bet or not bet at all. Just watch and learn and wait for the PD'A. No one seems to be disturbed if an already qualified horse races conservatively and finishes out of the money. Or as in the case of the guaranteed starter Bold Eagle, his team decided to race him very aggressively in one of the qualification races. Only they know why. He finished sixth. He then came back and won the next qualification. The crowd loved it. That's what separates us from casino gambling. The living, breathing, muscle and sweat element.

And finally, to answer Mr. Zelkin's question about big fields. Those races with really big fields would be impossible with a starting car. The standing start makes it possible.
