# OHHA vowing to fight for its survival in Ontario

*The existence of the Ontario Harness Horse Association is in jeopardy after a decision by Ontario Racing to transfer track revenue to rival Central Ontario Standardbred Association as of April 1.*

The Ontario Harness Horse Association (OHHA) is vowing to fight a decision that it says, "if not reversed, will effectively end" the association by "withdrawing its funding" and allowing the Central Ontario Standardbred Association (COSA) to offer benefits coverage to all standardbred horsepeople in Ontario as of April 1.

The decision to allow COSA to offer benefits province-wide and to direct OHHA's track revenue to COSA was made by Ontario Racing (OR), the umbrella group that manages horse racing in the province. COSA has a seat at the OR table, but OHHA does not.

OR chair John Hayes said, "COSA represents the Ontario

horse owners, trainers, grooms on the Ontario Racing board. The redirection of funds... relates to purses paid and the deductions from those purses that are set aside for benefits at the Ontario racetrack members of the OR association."

OHHA, formed in 1961, currently represents horsepeople at most of the province's smaller tracks. Annual OHHA membership fees are \$12.

COSA, formed in 2009 when OHHA failed to reach a contract with the Woodbine Entertainment Group (WEG), represents the horsepeople that race at Canada's largest racetrack, Woodbine Mohawk Park. It is free to become a member of COSA.

The majority of OHHA's funding comes from a purse deduction of 1.5 per cent from most of the province's tracks (other than Woodbine Mohawk Park). In its 2017 financials, OHHA reported membership fees amounted to \$12,713 dollars, just 0.02 per cent of its total income of \$763,122, of which \$386,731 came from track revenue (the 1.5 per cent from purses).

Hayes said, as of April 1, that track revenue money would go to COSA to run the benefits program across Ontario.

"The OR board was of the opinion that those funds should be directed to COSA and the member racetracks of OR, rather than OHHA," Hayes said. "COSA is the member on the board and we just wanted to be sure that those funds went to COSA to distribute to their members.

"COSA has opened up membership in their benefits to anyone in the province and I believe that all you need to join COSA is to show that you've got an AGCO license and that you are a member of Standardbred Canada (and you have an Ontario Health Insurance Plan (OHIP) card). So, there will be absolutely no horseperson in the province without benefits and we all know how crucial benefits are to individuals these days."

COSA president Bill O'Donnell said, in addition to the track revenue, OHHA has been receiving some \$25,000 per month – a total of \$294,881 as reported by OHHA's 2017 financial statement and listed under "provincial government contribution to member benefits." O'Donnell said that money comes out of purses and that COSA will not need that money to manage the benefit program, leaving it in purses where it belongs.

"We were in a meeting one day and it said in the financials '\$25,000 (per month) to OHHA.' I said, 'What is that?' and they said they've been giving \$25,000 a month out of the purse money, over and above the 1.5 per cent they get. They couldn't operate without that," O'Donnell said. "At that point, we could've taken it over and with our 1.5 and their 1.5 we could have supplied these benefits with no additional charge to the purse account whatsoever."

O'Donnell said he was told by the Ontario Lottery and Gaming Commission (OLG) that the additional \$25,000 per month was due to end sometime this year and that his biggest concern was that when that money stopped flowing, OHHA might not be able to continue to afford to offer horsepeople benefits.

"Do we want to see people without benefits? Absolutely not," O'Donnell said.

Even with the \$294,881 in additional money to help fund benefits, OHHA operated at a loss of \$28,881 in 2017.

By comparison, COSA's financials show a loss of \$20,414 for 2017 and revenue of \$601,066 from its 1.5 per cent cut of the purses at Woodbine Mohawk Park.

Should the decision to transfer OHHA's track revenue to COSA stand, using 2017 numbers as an example, the \$386,731 OHHA received from track revenue would give COSA revenue of \$987,797 to run the benefits program.

O'Donnell and Hayes were interviewed by phone for this

story. OHHA president Jim Whelan was offered the same opportunity, but he declined a phone interview, saying he would only agree to an in-person interview, despite a looming deadline and some 100 miles between himself and this story's reporter. HRU was not prepared to give him special treatment.

Whelan was quoted in an OHHA press release of Feb. 5 as follows, "If our members felt that they would be better represented by COSA, they certainly could have joined that association and sought to have it administer benefits, and insurance at their tracks... In 1962, OHHA was established by horsepeople out of necessity to fight for the interests of standardbred racing in Ontario, at all levels of government. We aren't prepared to let Ontario Racing take that right away from us."

In that same release, OHHA general manager Brian Tropea was quoted as saying, "OHHA represents the interests of standardbred horsepeople across Ontario and has a long history of successfully administering health and insurance benefits and a retirement savings program for horsepeople, without controversy or issue. Standardbred horsepeople will not take this lying down. Our members are ready to fight."

OHHA has been lobbying politicians to help them fight the decision. On Thursday (Feb. 7), OHHA's Whelan, Tropea, Tom Bain and Mark Williams met with Chatham-Kent-Leamington MPP Rick Nicholls. Tropea's Facebook page said OHHA had a meeting at the Ministry of Finance on Friday.

Meanwhile, O'Donnell said COSA has changed its bylaws to be able to represent anybody in Ontario, not just those that race at Woodbine Mohawk Park.

"We'll have representatives at each track, whether we do it election wise or we appoint people, I'm not really sure, but are we just going to leave them out in the cold? No, absolutely not."

O'Donnell strongly denied OHHA's contention that COSA was controlled by Woodbine.

"That's their opinion... They say, 'You're in bed with WEG and do whatever they want...' Did (WEG) want to build a new paddock? Did they want to give us an extra \$15 million over the next three to five years (for purses)? (2019-01-13 HRU Edition - page 7). When we went in there they didn't say, 'We've got \$15 million dollars for you' I can guarantee you

that. Do they want to race for 222 races dates at year at \$183,000 a day? I can tell you 'No'. They wanted to race 140 days at \$160,000 a day. That's what they wanted to do – not race in January, February or March. We went in there and fought for months over that."

O'Donnell promised a seamless transition as of April 1 and the same membership benefits at COSA that people with OHHA now receive.

One difference between the two associations is the fact that at OHHA, every member is entitled to a vote. O'Donnell said COSA does not allow caretakers to vote.

"The only reason we don't is because they are employees," O'Donnell said, explaining that virtually no business allows its employees full voting rights to dictate how a business is run.

As for what happens on April 1, O'Donnell was clear.

"COSA is getting the 1.5 per cent from those other tracks and we're opening up the benefits if people want to come over here," he said. "If they want to stay with OHHA and OHHA wants to supply them benefits, so be it, but I don't think they can."

## Chicago leaves a void in harness landscape

According to legend, Chicago's Hawthorne Racecourse once raced a card in 50-degrees-below zero windchills back in the early '90s. Over the past couple of weeks, when temperatures throughout that area once again reached those rare frigid temperatures, there weren't any tracks around to race, period.

It's this time of year when Chicago harness racing is sorely missed. There's only a handful of tracks that race this time of year as it is, and only three of them throughout all North America (Woodbine, Cal Expo and the Meadowlands) are at least 7/8ths in size.

Throughout this winter, handle at those tracks has generally been strong. The Meadowlands in particular, has been handling close to or above \$3 million on all racing nights over the past couple of weeks and it goes to show that no matter the quality, people will still bet big-size track harness racing.

One person who knows this best is Dan Nance, a trainer on the Chicago circuit throughout the 1980s and '90s and at one time was dubbed as Chicago's "claiming king." Now residing in Las Vegas though remaining an avid bettor of harness racing, Nance says "Chicago always had the second-best handle in the country, behind the Meadowlands. Bar none, always. So, the handle was always there at Hawthorne back in the 1980s, and people have always loved

Chicago harness racing. Now today, handle has dropped a bit at Hawthorne when they race in the summertime, but they'll still do a million if there's enough races on the card, but the problem is there's hardly any dates now.

"It's totally different now because back in the '80s we raced at Hawthorne in the winter time and we had doubleheaders twice a week, and overall we raced every night of the week except for maybe one night. It was so great and everybody loved it, the place was amazing. We would handle upwards of \$2 million a card, and I'm talking about on-track even before simulcasting became really big! The races were always good and horsemen loved to go there because the purses were the best."

Another signature of those strong winter Hawthorne meets was the toughness of it. In addition to the best trainers and drivers, Hawthorne racing endured through typical Chicago winters. Perhaps it points to a larger change in the sign of the times, but today most harness tracks in the winter will cancel at the slightest indication of potential inclement weather. This wasn't always the case.

"Let me tell you something," said Nance. "When I raced, you don't even know the kind of weather we raced in. We raced in blizzards when they had to scrape the track after every race but we still got the 10-race card in. It would snow in blizzard conditions and very seldom did they cancel. In the dead of

winter it could be 10 degrees below, 15 below, 40 below we raced in. One day in 1990 we raced in 50 below windchills. I remember two-horse races and three-horse races, but we raced, the horsemen raced, and now they cancel for every little thing."

In addition to Hawthorne and its rival Sportsman's Park throughout the '70s and '80s, bettors were attracted to the racing from Balmoral Park and Maywood Park almost up until the very end for both tracks. Though closed in 2015 as a harness facility, today Balmoral Park features show jumping horse competitions. There has not been as lucky a fate for Maywood Park. It was announced just this week that the former track will be demolished by the end of this year to make way for three industrial buildings. But it wasn't always that way.

Both tracks ran at the same time throughout the '80s and '90s, before switching to an alternating format between the two. "Towards the end, Maywood raced Thursday and Friday and then Saturday and Sunday was Balmoral, but they raced all year round," said Nance. "And you had real racing. From when I retired in 1999 through 2005 the racing was still great. You still had (Tony) Morgan here, Tetrick, Andy Miller here, all the good drivers and purses were still really good. And then in 2005, Morgan was the first one to leave and

then the exodus happened. That's when the racing took a dive, the entire product. But, at least it was still there and people still bet on it. Maybe not on a Thursday but on a Friday Maywood would outhandle everyone. Their Friday nights would get \$800-\$900K and now what do you get? We have nothing."

Indeed, both tracks would be useful right now. The mile track at Balmoral is something that would attract big handle today, and even the aggressive racing style from Maywood's half-mile track would be desirable compared to its counterpart half-mile tracks today, which contain lesser action. Even though the quality of horses and the overall product was far from what it resembled in its heyday, the tracks featured a style of racing that isn't seen today outside of maybe a couple of tracks.

As winter racing continues to plod through the remaining weeks, until more tracks come back in the spring, consider me someone who thinks Chicagoland racing is missed. Not only for the simplicity of having more winter racing, but for the throwback to when racing was at its competitive best.

## Judith Bokman – Standardbred Retirement Foundation, the angels of harness racing

There are many organizations whose goal is to help horses. Fortunately, for the horses of harness racing there is the Standardbred Retirement Foundation. The oldest standardbred rescue group, SRF gives horses dignity and a chance beyond the oval.

The angels that are responsible for this award-winning, wonderful organization are two women named Paula Campbell and Judith Bokman. Both ladies are no strangers to the sport. Paula's husband is John Campbell, one of harness racing's top drivers; and Judith's husband is equine veterinarian Dr. Bokman.

"In 1988, Paula and I had a one-minute conversation that led to the birth of SRF. It was the first time we ever met, but we both had the same goal: to help these horses. SRF is the only standardbred-specific organization that has 190 retirees under its care and nearly 400 trotters and pacers under its expense. How it differs from other organizations is that SRF actually protects every horse for life. It never relinquishes ownership, so if an adopter can no longer provide good care, the horse must be returned to SRF. It also follows up semi-annually for the life of each horse, requiring a report from the veterinarian.

"We recently had a case, a horse named Letter Kenny Lad N, came back to us from a therapy program. He was a 32-year-old senior. Had we left it to the adopter to move the horse on, where would he be?

"Relinquishing these horses defeats the good use of support from donors and puts these horses at risk. It makes no sense. In our care, Kenny lived another year and today he is pain-free living in peace, racing his friends up there."

Judith rode horses as a young girl every Sunday on the beach. After graduating from college with a Bachelor's degree in Education, she worked as an international flight attendant. That is about the time she met Paula and together they founded SRF.

Judith owned a racehorse at one time, but when she was forced to race him in claiming races that was enough for her. She put a saddle on the New Zealand-bred pacer while he was still racing and found the perfect horse.

"At SRF we have two adoption coordinators, one herd manager, one caretaker, one fundraiser, a part-time social media and graphic designer, and a part-time bookkeeper. Remember, we manage 400 horses, and follow up on thousands," Judith said.

"I oversee the staff, help in fundraising, compliance with the state and federal government, the budget, consult on all issues of managing the large herd, and the semi-annual follow up. I am the 'go to' person for all medical issues as there are problems after problems with lameness, shipping, quarantine, non-compliance by adopters... and the list goes on and on.

"Our biggest hurdles are fundraising and horse management. Fundraising is extremely difficult and the cost of care, training, veterinarian and blacksmith expenses, the adoption, and the follow-up process are great. Think about what it would cost a day to care for 400 in a racing stable? SRF has no endowment and no farm. There are no government grants and no harness racing grants. SRF's funding comes primarily from donations, kind hearts, the general horse loving public and folks who have owned racehorses or still do and step up to help."

At SRF, there is no special preference on the care one horse gets over another. They are all treated and cared for equally.

SRF has had the Hambletonian winner Shiaway St. Pat and still has Swinging Glory, and many more. But they are all special to this wonderful program – no matter their pedigree, age, sex, etc.

"The worst part of my job is seeing so many racehorses crammed in kill pens," Judith said. "People think selling to dealers who come to the tracks and training centers and turn around and sell to rural communities is a good thing. I say, 'Come to SRF and see the abuse and neglect these horses have endured there, and that's if they didn't already run through the livestock sale and ship for slaughter.'

"We get a great many of these trotters and see only about one per cent in adequate condition. The others are emaciated, have suspensories dragging, are sick, their feet and teeth have been neglected and much more. I am at the point where I can deal with humane euthanasia, rather than see them suffer.

"Working with SRF I have met the worst and greatest people. Our donors touch me for they are so special. Our foster homes are fabulous and we are lucky to have so many wonderful adopters. When we get an abuse or neglect case I hear the staff whisper some tough language, but there are other days where the 'oohs and ahhs' are tremendous. These horses touch and change a lot of lives. It's so sweet."

## Staying Together - the oldest living Horse of the Year

Staying Together, the 1993 Horse of the Year at age 4 is now 30. That makes him the oldest living Horse of the Year winner.

Staying Together was trained at 4 in his HOY season by Bob McIntosh, who had not trained him prior. The pacer, owned by Robert Hamather, currently lives at Kentucky Horse Park.

Staying Together set the world race record of 1:48.2 in 1993 at the Meadowlands.

Bill O'Donnell was his regular driver.

The HOY award came the year after McIntosh trained another Horse of the Year, Artsplace — another 4-year-old he had previously not conditioned that also set the world race record (1:49.2). NOTE: They set the record in the very same race, the Driscoll series, which was renamed the William Haughton in 1999.

"I thought (Staying Together) was the best 3-year-old of 1992," McIntosh said. "One day Bob Hamather called me and asked if I would consider training him at 4. I said 'Are you kidding? I love that horse. Yes!'

"Staying Together was a very special horse. A throwback. He was coarser than a lot of the standardbreds at that time. He had one helluva set of lungs. He wanted to win. He was also low maintenance. I think I was at Greenwood when I got the call that he won in world record time (1:48.2-June 19, 1993). I was shocked, but I knew he was capable of great things."

McIntosh is a seven-time Canadian Trainer of the Year that is in the Hall Of Fame both north and south of the border. His first Breeders Crown win came in 1986 at Garden State Park with Sunset Warrior. His North America Cup win with Thinking Out Loud was his biggest purse victory, and he's training that homebreds' first full crop in 2019.

"I train only my own — all homebreds. I am pretty high on

my 2-year-olds who just turned 3 and the yearlings who turned 2. I didn't have any 3-year-olds last year of note. The last couple of years have been a little drier. I don't like to get ahead of myself, or get too high on the 3-year-olds, but I like what I see for sure right now."

### Blair Burgess is the only trainer...

... to ever have a North America Cup, Meadowlands Pace, Little Brown Jug, Hambletonian and Triple Crown winner.

His 2002 HOY Real Desire was the fastest of his age group all three years he raced — 2-3-4. Burgess won the Meadowlands Pace with 14 years in between Frugal Gourmet in 1987 and Real Desire in 2001.

### Same crop

In 2018, we had four outstanding 3-year-old trotting fillies — Atlanta, Manchego, Plunge Blue Chip and Phaetosive — all banking over \$500,000. Where have all the rivalries gone?



In 2001, Bettors Delight battled Real Desire.

In 1987, it was Mack Lobell vs. Napoletano.

In 2000, Dragon Again waged war with Western Ideal.

In 1991, it was Precious Bunny vs. Artsplace

## **Austin Siegelman reflects on career-best 2018 campaign; looks ahead to 2019**

Austin Siegelman put up career-best numbers in 2018 and is looking to parlay that success into even bigger numbers this year. Siegelman, who turns 27 on Feb. 27, won 314 races and \$2.19 million in purses last season. His win total ranked 26th among all drivers in North America.

"I think I had a pretty good year," Siegelman said. "I think it was a step in the right direction if my career is going to go forward. I really didn't expect it to happen because I didn't have a steady barn to drive for, and I kind of still don't. I'm just going to take it for what it is. Hopefully I can build off it and it gets a little better this year."

Siegelman enjoyed the majority of his success at Monticello Raceway, where he finished third in the driver standings with 229 victories despite missing three weeks as the result of an accident. His 18-per cent win clip was also third among regulars at the upstate New York half-mile oval.

In September, Siegelman added New Jersey's Freehold Raceway to his schedule. He won 32 races there during the remainder of the year, a total that was fourth best at the track. He also had wins at the Meadowlands, The Downs at Mohegan Sun Pocono, Tioga Downs, and Yonkers.

"It was nice to get 200 wins at Monticello," Siegelman said. "It was nice to get into Freehold towards the end again. It was really nice to break into Yonkers a little bit. That's where I'm looking to go."

Siegelman is currently focused on driving at Monticello, Yonkers, and Freehold. He began racing regularly at Yonkers last July and has won 38 races there.

"I'd like to drive at the Meadowlands more, but my schedule is nice and tidy with Monticello Monday through Thursday, Freehold on Friday and Saturday, and Yonkers the five nights," Siegelman said. "It's a full book."

"I'd like to pick up a little more quality work at Yonkers and cut down a little. That way it's not just a mad rush every day. It's tough. It's tough on the body, it's tough mentally. Sunday is my only day off now and I don't want to do anything."

Siegelman, the son of trainer James Siegelman, received

the 2013 Rising Star Award from the Monticello-Goshen chapter of the U.S. Harness Writers Association. Last September, he got career win No. 1,000, which came at Monticello.

"For sure, that was the highlight of last year," Siegelman said. "That was nice."

Siegelman does not set many goals each year, other than continuing to improve.

"I watch replays when I'm off. I watch races. It doesn't stop," he said. "I want to learn. I know the mistakes I make when I'm out there. As soon as I make them I'm like, 'Oh no.' It's not a good feeling."

"I think I'm finally learning to be a little more patient and play the gate a little better. I used to have it in my head before the race what I was going to do — if I was going to leave, or if I wasn't — and now most of the time I let the horse decide. I think I'm starting to get a little more polished. I'm still not there yet."

Patience can be difficult for young drivers to achieve, especially as they strive to make a name for themselves.

"I want to win every race that I'm in," Siegelman said. "It's a tough pill to swallow that I can't."

Still, Siegelman is happy with the progress he has made so far in his career.

"I'm finally getting to a point where I'm happy with where I'm at," he said. "I just take it day-by-day."

## **Kerin Warner embraces new role at SUNY Morrisville**

When Kerin Warner got a degree in history from Rutgers some two decades ago, he already knew his future was with racehorses and not students in a classroom.

The education he gained during the ensuing years, though, has now led the 45-year-old Warner to the role of teacher.

Warner is the new instructional support associate for the standardbred program at SUNY Morrisville. The program emphasizes hands-on participation in the breaking, care, training, conditioning and racing of standardbreds through requisite courses such as equine anatomy and physiology, stable management, breeding management, nutrition and training. Students receive an associate in applied science degree in equine racing management.

"I saw it as a great opportunity," said Warner, who shut down his stable in northern New Jersey to take the position at Morrisville, which is located 30 miles southeast of Syracuse. "I'm just going to take it and run with it. I'm going to try to make it big."

Warner, who grew up near Freehold, followed his father, trainer/driver Warren Gabettie, into harness racing. Warner considered going to veterinary school, but ended up helping with his father's stable after Gabettie became ill while Warner was at Texas A&M. Warner got a degree from Rutgers, but the horses would be his career.

"I never wanted to be a history teacher; I just finished up a degree," Warner said. "I knew I was going to be in the horse business when I figured out I wasn't going to be a veterinarian."

"I thought this was a cool opportunity. It's a great college. It's a big program, a big school. I grew up in this business. My father was a trainer, my uncle Bobby was a trainer. I think I owe it to give back. I'm trying the best I can right now."

Prior to joining Morrisville, Warner focused on breaking yearlings for other owners and trainers in addition to training a small stable, most notably the "Munn" horses of breeder/owner George Munniksma. Warner has won 350 races as a trainer and 24 as a driver.

Morrisville's equine center features the nation's only half-mile harness racing track on a college campus, as well

as rehabilitation, breeding, and training centers.

Students work with assigned horses and, upon successful completion of the U.S. Trotting Association's driver/trainer test and other mandated requirements, can race those horses on the New York county fair circuit or amateur events at local pari-mutuel tracks.

The school also offers a bachelor of technology degree in equine science for students interested in continuing their studies.

"They have state-of-the-art facilities," Warner said. "It's a good opportunity for the kids; they learn a lot."

"I fell in love with the place the minute I was there."

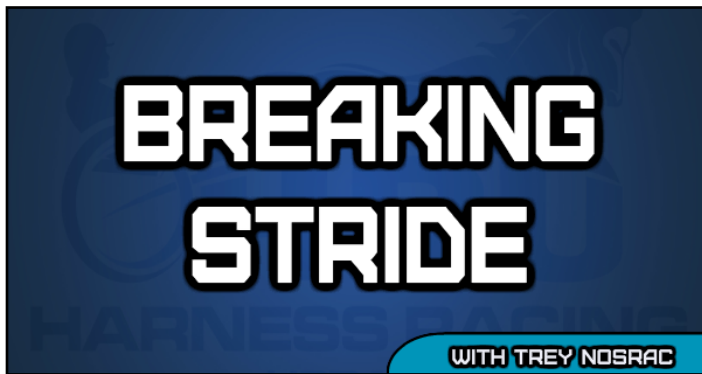

"Not exactly. A racetrack is what you might call a second-tier plan. Our primary plan is tourism and doesn't depend on gambling. I found the exact location and the wheels are already turning."

"And the winner is?"

Look at the southern tip, near Hardeeville, on I-95. I've stayed there several times. It has lots of open space. Hardeeville has so many benefits for this harness racing idea it's scary. The weather and the travel demographics that flow



through this route would make your jaw-drop. Over one hundred million people visit Florida each year and this is the main artery. Hardeeville is a great stop for the flocks of snowbirds that drive to Florida. They have about 20 hotels and it's a good place for travelers to catch their breath before pushing on to Florida."

"You're after tourists and travelers?"

"Bingo. The first stage is a training facility for harness horses."

He opened his hands as if he was catching raindrops, "Trey, I was expecting more from you. A training center is nothing new. I think South Carolina already has one in Aiken. They can't be big money-makers."

"Ah Grasshopper, listen with open ears. Hardeeville is on the way for people traveling I-95 from Canada to Florida. Hilton Head, Bluffton and Savannah are all within a 30 to 40-minute drive."

"Still, Trey, a training center is not terribly innovative."

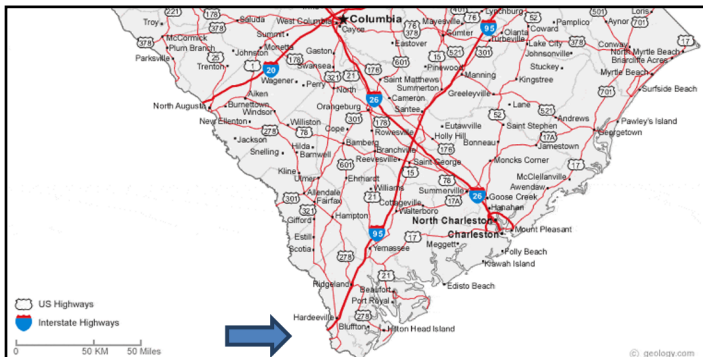
"Here is where I get innovative and terrible." I paused for dramatic effect, "This training center will be either on the grounds of, or right next door to, a massive RV park."

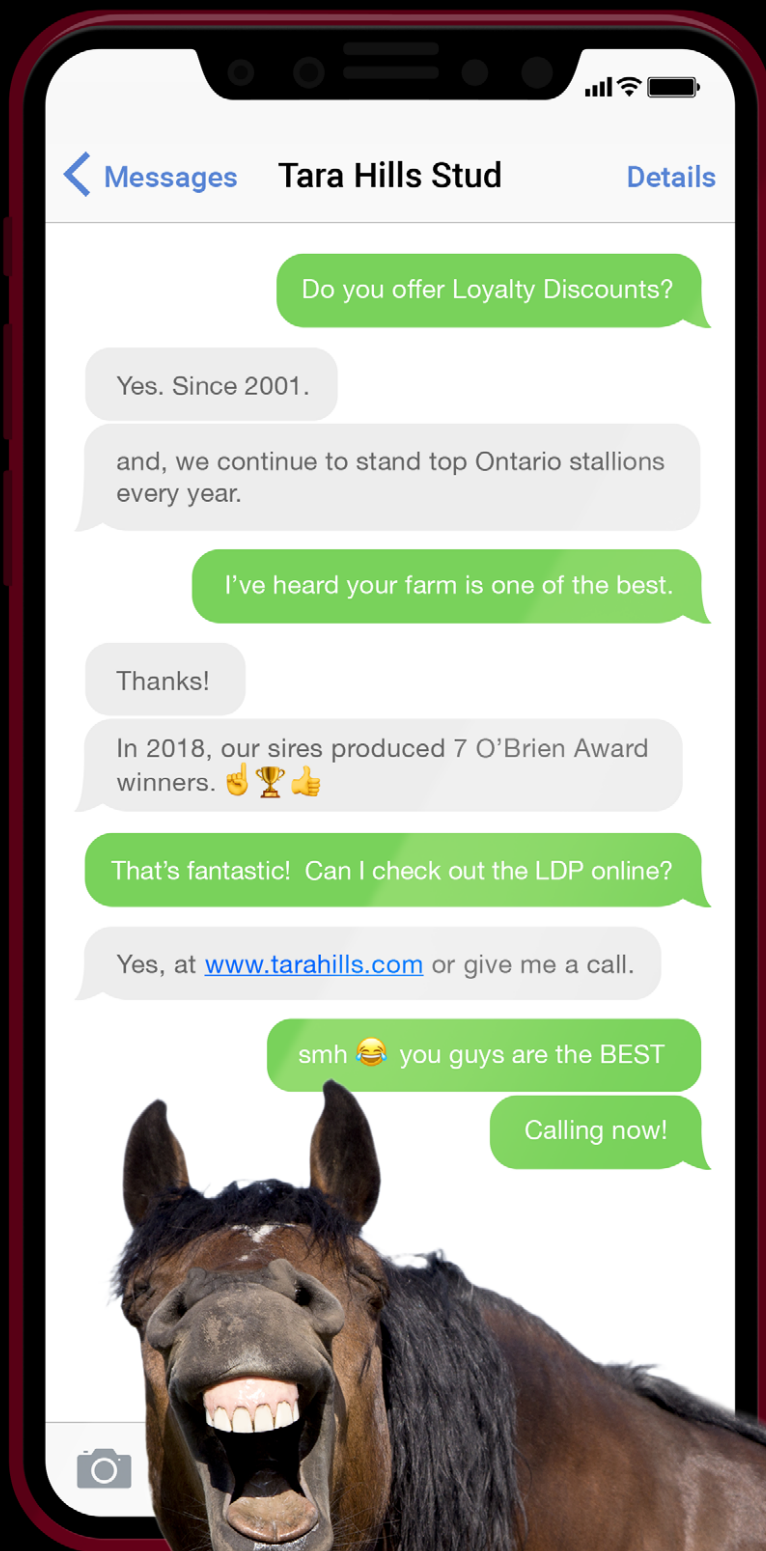

The red-hot 6-year-old son of Donato Hanover—Lakeside Bride, who benefited from great driver Marcus Miller handling, won his fourth feature in his last five tries and sixth race in his last seven overall.

Sent off as the 2-5 public choice, Miller had Trolley on the go from the start but was pushed wide into the first turn. Miller opted to settle his horse into the five-hole instead of going on with it, and that may have made the difference. Misslarose, up in the Preferred ranks off consecutive wins with high-class conditioned foes, moved past early leader Derf Hanover after the quarter and hit the half in :57.

Cash Me Out was racing first over at the half, providing a perfect second-over trip for Trolley, who stayed with that cover into the stretch before tipping with a little more than an eighth of a mile to go. The Erv Miller trainee needed every inch of the stretch to get past a stubborn Misslarose, but he collared the leader nearing the wire, before going on to a half-length win in 1:55.1 on an extremely windy East Rutherford night. Cash Me Out finished third.

Trolley returned \$2.80 to his backers while staying perfect in three starts this year. Overall, he's won half of his 28 lifetime outings and earned \$323,951 for owners Michael Anderson, Leland Mathias, Greg Gillis and Louis Willinger.

**GINGRAS STAYS HOT:** Driver Yannick Gingras continued his winning ways, scoring five times on the program. After 13 winner's circle visits last weekend (Feb. 1-2), 'The Green Hornet' has now won 18 of his last 38 Meadowlands' drives.

## Richard Young responds to As-Is Clause story

I'd like to clarify statements made by Mr. Russell Williams, president of Hanover Shoe Farms ([full story here](#)).

He states we tried to argue that the AS IS clause was no longer the law so we don't have to go to trial and that we lost. We didn't do anything resembling that. That was never our intent. Our first defense was it was standard practice to return such horses and that horses in conditions such as Eloquent Diva's, the breeders would take them back. However, we did not want to rely on that defense alone, even though we thought we would be victorious. We filed for a summary judgement ruling on a breach of express warranty, which is the law in PA. We knew we had virtually zero chance of winning the summary judgement as it would strike down the AS IS clause. That would not happen. Judges seldom make summary judgements as they create precedent. This in no way says the judge ruled against us as was suggested. He simply decided not to grant summary judgement.

Express warranty is when there is a communication by the seller or a representative of the seller to the buyer stating the effectiveness or positives of the item, in this case the horse. It may also include certain advertisements. Breach of express warranty voids the AS IS clause. Contrary to what was stated, there was such communication admitted at trial. The purpose of us to do this was to get this defense in as an option for the jury to consider in deciding the case. We wanted the judge to consider this going forward. As you can imagine, there was considerable discussion concerning this defense in judges' quarters as the plaintiffs did not want it to be included. As you all now know, it was included as an option for the jury to consider and was included in the jury instructions. So, the reality of trying the summary judgement was in effect a win for us not a loss. If the jury decided I was in breach of the contract by not paying for the horse, they could decide that there was a breach of the express warranty by the sellers in which case we would still win. As it turned out, it was never required to consider this defense as the jury

decided we were not in breach of the contract to pay for the horse.

Upon reading the statements made by Mr Williams, I'm not sure if there was intent to give the impression that the jury may have felt sorry for me for having to pay for a horse destined to die and that they solely believed that and I still should have lost. Upon hearing the jury's verdict, the judge thanked the jury and said, "You made the right verdict." I guess that tells the real story.

This does state one thing especially when buying a racehorse not a yearling. Seldom does a seller of a yearling train the horse and then say how good it was. If the seller makes incorrect statements concerning his horse such as he has never had surgery and you find that he had say throat surgery, in PA he may be in breach of an express warranty. Food for thought.

## Another legal opinion on Richard Young case

Since I am both a small commercial breeder and an attorney, I read with great interest the Harness Racing Update on the litigation involving Richard Young's purchase of a yearling filly named "Eloquent Diva" at the 2013 Harrisburg Yearling Sale and would like to give you my thoughts on the matter.

The "Uniform Commercial Code" (U.C.C.) was formulated by the Uniform Law Committee in order to harmonize the various state laws that govern commercial transactions, i.e. the sale of "goods", which includes horses. Each of the 50 states have adopted its own slightly different but basically the same version of the U.C.C.

The U.C.C. provides that where the seller has reason to know of any particular purpose for which the "goods" are required by the buyer (such as training and racing in the case of yearlings), there is an implied warranty that the goods shall be fit for such purpose UNLESS SUCH WARRANTY IS EXPRESSLY EXCLUDED by the seller through the use of such terms as "as is" or "with all faults", terms that are included in every sale catalogue that I have seen. The U.C.C. further provides that when a buyer has examined the goods before purchase, OR HAS REFUSED TO DO SO, there is no implied warranty with regard to defects WHICH AN EXAMINATION OUGHT TO HAVE REVEALED TO HIM.

Pennsylvania has essentially adopted the foregoing provisions of the U.C.C. and they are therefore applicable to



Mr. Young's purchase of Eloquent Diva.

I have no knowledge of the facts of this case other than what I have read in Harness Racing Update. According to the "facts", as stated by Mr. Young, Eloquent Diva had a serious congenital heart defect at the time he purchased her, which condition his vet discovered two days later when he put a hand on the filly's chest and immediately said "we have a problem here". This condition would therefore have been just as evident to Mr. Young had he elected to have his vet "put a hand to her chest" before he purchased her.

Since the Harrisburg Sale Catalogue provided that "ALL HORSES ARE SOLD AS IS WITH ALL FAULTS AND DEFECTS", and Mr. Young admits that he did not have a vet examine Eloquent Diva before he purchased her, the seller did not warrant, by implication, that she was fit for training and racing and the only way Mr. Young could have prevailed was to show that the seller knew of her condition before the sale and failed to disclose it. However, Mr. Young admits that he "...didn't argue that (the breeder or seller) knew, because it didn't matter if they knew. They SHOULD HAVE KNOWN, that's really what it comes down to."

The legal issue raised by Mr. Young's litigation is therefore this:

Where a buyer purchases a yearling "as is" and "with all faults and defects", and did not have her examined by a vet before her purchase, which examination would have disclosed the defect he complains of, can he never-the-less refuse to pay for the yearling by claiming that the seller should have known of the defect?

My answer to this question is "no" since I do not believe this to be the law in Pennsylvania, or any other state that I am aware of, and in my opinion this case should never have gone to a jury. It is the province of the trial judge to determine the law applicable to a given case and the province of the jury to resolve any dispute in the facts. However, the facts in Mr. Young's case were undisputed and the law clearly supported the seller. The trial judge should therefore have entered a summary judgment in favor of the seller before trial or entered a directed verdict in his favor at the close of evidence. The judge failed to do either and the result was a "do right" verdict that was contrary to both the law and the evidence.

In any event, the judgment in Mr. Young's favor does not set any kind of a precedent with regard to the sale of horses "as is" since it apparently was not appealed and only appellate courts can set precedent. Any change with regard to the sale of horses "as is" would involve a change in the U.C.C. or a change in the terms and conditions contained in the sale

catalog.

As a footnote, the version of the U.C.C. adopted by Kentucky specifically provides that there is no implied warranty that animals are free from disease or sickness UNLESS THE SELLER KNOWINGLY SELLS ANIMALS THAT ARE SICK OR DISEASED.
